Fr. Varghese Mettekkattu, aged 40 (Forty) years, Priest, son of Mr. Xavier, residing at Oblates of St. Joseph, Kodungallur, Lokamaleswaram Village, Kodungallur Taluk, Trichur District, Kerala State, hereinafter referred to as the SETTLER, settling it on Rev. Fr. John Attully, aged 49 (Forty nine) years, Priest, son of Mr. Antony, residing at Marello Home, Aluva, Aluva West Village, Aluva Taluk, Ernakulam District, Kerala State hereinafter referred to as the TRUSTEE.

WHEREAS, the Congregation of Oblates of St. Joseph (OSJ) has started its activities in India by starting its first house at Kodungallur in Trichur District during 1962.

AND WHEREAS, the Congregation has started various Religious Educational and Charitable activities for the benefit of the poor and needy at different parts of Kerala.

- 1) NAME OF THE TRUST: The Name of the Trust shall be OBLATES OF ST. JOSEPH EDUCATIONAL AND CHARITABLE TRUST.
- 2) REGISTERED OFFICE: The Registered Office of the Trust shall be at Kodungallur in Trichur District. The Trustees are at liberty to change the registered office to anywhere else in Kerala with the approval of the Settler.
